Scope of processing on the basis of this consent: E-mail address

Purpose of processing: Sending of commercial notices

Data processing period: The consent is granted for the period of 10 years or until withdrawal of the consent.

Processors and other recipients of personal data. The Controller transfers personal data processed on the ground of this consent to the processor, provider of e-mail marketing platform: **ECOMAIL.CZ, s.r.o.**, reg. no: 02762943, registered office at Na Zderaze 1275/15, 120 00 Prague 2, Czech Republic.

The Controller transfers personal data processed on the ground of this consent to another controller: **PROBINEX LIMITED**, reg. no. HE 424251, registered office at Riga Feraiou 4, Omega Court 1st floor, 3095 Limassol, Cyprus. This controller is entitled to use personal data only for sending of commercial notices.
